A: IZJAVA UPORABNIKA

Zavedam se možnosti povečane nevarnosti poškodb.

Za svoja ravnanja in posledice prevzemam polno odgovornost.

Zavežujem se, da bom ravnal odgovorno in skrbno tako do sebe, kot do ostalih udeležencev parka.

Prav tako bom upošteval svoje znanje, izkušnje in telesne zmožnosti, vključno s svojim zdravstvenim stanjem.

Sprejemam vsa **navodila za varno uporabo naprav** upravljalca trampolin parka Woop! Ljubljana. Zavežujem se, da se bom z vsemi navodili skrbno seznanil ter jih dosledno upošteval, vključno z ustnimi navodili osebja. Strinjam se, da me ob nespoštovanju varnostnih navodil osebje lahko odstrani iz trampolin parka Woop! Ljubljana brez povračila cene vstopnice. Soglašam, da neposredni nadzor skladnosti mojega ravnanja z navodili ni potreben.

Jamčim, da so moji podatki v zvezi s starostjo in zdravstvenim stanjem resnični. Nisem (in v bodočih obiskih ne bom) pod vplivom alkohola ali drugih opojnih substanc.

Nimam bolezni ali telesnih okvar, ki bi pri dejavnostih v trampolin parku Woop! Ljubljana pomenile nevarnost za mene ali druge. Nisem v stanju nosečnosti. Nimam težav s senzorno občutljivostjo.

Strinjam se, da moje obveznosti, sprejete s podpisom te izjave, veljajo za vse obiske v trampolin parku Woop! Ljubljana še eno leto od podpisa, da pred vsakim obiskom v tem obdobju ni potrebe po vsakokratnem podpisu izjave. V primeru sprememb zdravstvenega stanja, stanja telesa se zavežujem spremembe sporočiti upravljalcu trampolin parka Woop! Ljubljana. Če izjave ne prekličem ob prvem obisku po preteku enega leta od podpisa dalje, izjava velja za nedoločen čas, z možnostjo preklica.

B: NAVODILA ZA VARNO UPORABO NAPRAV

Skakanje na trampolinah je ob upoštevanju navodil povsem varno. Vsa navodila za varno uporabo so na voljo kot del »Izjave o odgovornosti« in kot del spletne strani www.woopljubljana.si/varnost. Navodila so predstavljena tudi v obliki video zapisa v prostorih parka, dodatno pa navodila predstavijo usposobljeni animatorji.

Pri obisku in uporabi vseh naprav v trampolin parku Woop! Ljubljana veljajo naslednje omejitve:

1. Odrasli in otroci nad 15 let uporabljajo naprave samostojno, po podpisu »Izjave o odgovornosti«.
2. Otroci od 9 do 15 let uporabljajo naprave samostojno, ko »Izjavo o odgovornosti« podpiše njihov zakoniti zastopnik
3. Otroci od 3 do 9 let lahko uporabljajo naprave zgolj v spremstvu zakonitega zastopnika (skačeta skupaj, zakoniti zastopnik nadzoruje skakanje otroka), po tem, ko zakoniti zastopnik podpiše »Izjavo o odgovornosti«.

Za obisk in uporabo naprav v trampolin parku Woop! Ljubljana je potrebna predhodna registracija na spletni strani www.woopljubljana.si. Registracijo lahko opravi oseba, starejša od 15 let, ki lahko navede tudi svoje družinske člane, mlajše od 15 let, za katere potrjuje »Izjavo o odgovornosti« (primer: eden od staršev pri registraciji doda tudi svojega sina mlajšega od 15 let).

Registracijo lahko opravi tudi oseba mlajša od 15 let, pri čemer mora v postopku registracije navesti vsaj enega od staršev oz. zakonitega zastopnika, ki bo v njegovem imenu podpisal »Izjavo o odgovornosti«.

Poleg potrditve »Izjave o odgovornosti« pri spletni registraciji je treba za prvi vstop v park oz. uporabo naprav to »Izjavo« tudi lastnoročno podpisati na recepciji parka. Za osebo, mlajšo od 15 let to storijo starši oz. zakoniti zastopniki.

Ob nakupu vstopnice oz. pred vstopom v igralni del parka mora vsak obiskovalec kupiti posebne protidrsne nogavice in posebno (RFID) zapestnico. Zapestnica omogoča nadzor vstopa in izstopa v igralni del parka, uporabo garderobnih omaric in ostalih atrakcij v parku. Vstop v igralni del parka je mogoč le po predhodnem ogledu videa z varnostnimi navodili, kjer je potrebna identifikacija z zapestnico. Zapestnica ni prenosljiva in jo lahko uporablja izključno lastnik profila na katerega se navezuje. V primeru zlorabe se zapestnico odvzame. V primeru izgube je potrebno doplačati za novo zapestnico.

Varnostna navodila, ki jih mora upoštevati vsak skakalec:

- Vstop v skakalni del parka je mogoč le v primeru nošenja protidrsnih nogavic s primerno podlago za boljši oprijem in posebne zapestnice (RFID).
- Za skakanje priporočamo uporabo lahkih športnih oblačil.

- Pri skakanju je treba slediti vsem varnostnim navodilom upravljalca parka in osebja.
- Pred skakanjem je treba odložiti ves nakit in ostre predmete.
- Vedno je treba imeti nadzor nad svojim telesom. To pomeni, da ne prekoračite svojih fizičnih zmogljivosti in da izvajate le aktivnosti za katere ste prepričani, da jih lahko izvedete varno.
- Vedno upognite kolena, ko se želite ustaviti.
- Vedno skačite v sredini trampolina in vedno pristanite z obema nogama hkrati.
- Vedno bodite pozorni na skakalce okoli sebe.
- Prepovedana je uporaba trampolina dvema uporabnikoma hkrati. Če kdo kadarkoli vstopi v vaš skakalni prostor takoj nehajte skakati.
- Prepovedano je skočiti na trampolin, ki je že zaseden.
- Prepovedano je pristajanje na glavi ali vratu.
- Prepovedano je pristajanje na hrbtu, razen na trampolinu, ki omogoča hojo po steni, za kar je potrebno predhodno znanje.
- Prepovedan je skok na glavo (zračna blazina, gimnastična jama s penami).
- Prepovedano je metanje žog v glavo ali vrat (pri igri med dvema ognjema),
- Prepovedano je izvajanje vseh salt, razen pod nadzorom animatorjev parka na pozicijah, ki so za to posebej označene.
- Prepovedano je skakanje s trampolina na podlago.
- Prepovedano je ležanje na blazinah in trampolinah.
- Prepovedano je odrivanje in tekanje.
- Prepovedano je plezanje in obešanje na varnostne mreže.
- Prepovedano je nošenje mokrih oblačil.
- Prepovedano je imeti v času skakanja karkoli v ustih (žvečilni gumi, bombon,...).
- Prepovedan je kakršenkoli vnos hrane v času skakanja.
- Prepovedana je uporaba trampolina pod vplivom alkohola ali drugih opojnih substanc.
- Prepovedana je uporaba telefona med skakanjem.

C: ODGOVORNOST UPRAVLJALCA

Upravljaec Trampolin parka Woop! Ljubljana je podjetje TPLJ d.o.o., Leskoškova cesta 2, 1000 Ljubljana (v nadaljevanju »upravljaec«).

Upravljaec za škodo, ki bi jo utrpeli uporabniki in obiskovalci na sebi ali svoji lastnini, ne odgovarja, razen če bi bila povzročena po njegovi krivdi.

D: VARSTVO OSEBNIH PODATKOV

Upravljaec osebnih podatkov, zbranih preko spletne strani, je podjetje TPLJ d.o.o., Leskoškova cesta 2, 1000 Ljubljana (v nadaljevanju »upravljaec«). Upravljaec osebnih podatkov ne bo posredoval nobenim tretjim osebam.

Upravljaec vaše osebne podatke zbira samo v kolikor se sami odločite, da mu jih posredujete – zbiranje je prostovoljno.

S posredovanjem podatkov soglašate, da upravljavec vaše osebne podatke in informacije hrani, obdeluje in uporablja za naslednje namene: komuniciranje z vami, statistična obdelava, segmentacija potrošnikov, obdelava preteklega nakupnega obnašanja, pošiljanje ponudb, gradiva in vabil, izvajanje neposrednega trženja (preko telefona, e-pošte, SMS sporočil in navadne pošte), ter telefonsko, pisno in elektronsko anketiranje.

Vaše osebne podatke bo upravljavec varoval in obdeloval v skladu z veljavnim Zakonom o varstvu osebnih podatkov (ZVOP-1). E: VIDEO NADZOR

Trampolin park Woop! Ljubljana zaradi zagotavljanja varnosti zaposlenih, obiskovalcev in premoženja ter nadzora vstopa in izstopa iz parka, izvaja videonadzor. Upravljavec je sprejel sklep o izvajanju videonadzora v skladu s smernicami Zakona o varstvu osebnih podatkov (ZVOP-1) in 75. člena o izvajanju nadzora v poslovnih prostorih Trampolin parka WOOP!. Zbirka osebnih podatkov vključuje sliko, datum in čas posnetka in je zavarovana pred dostopom nepooblaščenih oseb. Videoposnetki se hranijo najmanj 30 dni in največ eno leto za vse kamere, ki so priključene na napravo za snemanje. Podatki se nato brišejo, razen podatkov o poškodbah.

F: UPORABA SLIKOVNEGA in VIDEO MATERIALA

Obiskovalec soglaša, da lahko fotografije in video posnetke narejene v parku uporablja za javno objavo oz. objave namenjenim oglaševanju in promociji Parka. Takšne fotografije ali video material se lahko pojavijo na socialnih omrežjih Facebook, Instagram, Twitter, Youtube, LinkedIn ali Snapchat. Hkrati soglašate, da slike narejene v parku ne bodo uporabljene za komercialne namene brez predhodnega pisnega soglasja.

Should I wish to organize a birthday party at the Woop! Ljubljana Trampoline Park, I certify that I will inform the legal representatives (parents or legal guardians) of all birthday party attendees of the event. I agree to inform them of the provisions of this "Liability Waiver" and to obtain their full consent for the participation of all the attendees. I accept and assume full responsibility for complying with all of the terms set forth in this waiver.

A: PARTICIPANT CONSENT

I hereby state that my participation in the sports activities at the Woop! Ljubljana Trampoline Park is entirely voluntary and of my own volition.

I understand that the activities in the park involve an increased risk of injury.

I assume all the foregoing risks and accept personal responsibility for the damages following such injury.

I expressly agree to act responsibly and attentively with regards to both myself and others in the park.

I also agree to take into account my own knowledge, experience and physical abilities, including my health condition.

I accept all ***instructions for safe equipment use*** provided by the Operator of the Woop! Ljubljana Trampoline Park. I agree to thoroughly read and follow all instructions, including all verbal instructions of the park staff. I acknowledge that the staff has the right to escort me off the premises of the Woop! Ljubljana Trampoline Park without refunding my ticket, should they find that I do not conduct myself in accordance with their safety instructions. I concur that this does not necessarily imply direct supervision on their part.

I declare all my information regarding my age and health condition to be true. I am not under the influence of alcohol or drugs (and will not be during future visits).

I do not suffer from any illness or physical impairments, which would pose a risk to either myself or others in the Woop! Ljubljana Trampoline Park. I am not pregnant. I do not experience sensory sensitivity.

I hereby agree to assume all my responsibilities at the Woop! Ljubljana Trampoline Park, stated in this waiver, for a period of one year after having signed this waiver, and that during this period of time, I am not obliged to re-sign this waiver upon further visits. If my health condition should change, I promise to inform the management of the Woop! Ljubljana Trampoline Park. Unless I revoke this waiver during my first visit after the period of one year of signing, it will remain valid for an indefinite period, although it can still be revoked, should I choose to do so at a later time.

B: INSTRUCTIONS FOR SAFE EQUIPMENT USE

Jumping on the park's trampolines is completely safe if you follow all instructions. All instructions for safe use of park equipment are contained in the following section of this "Liability Waiver" and on the following webpage: www.woopljubljana.si/varnost. Inside the park, instructions are first presented in the form of a video while further instructions are then given by qualified animators.

During your visit and use of the Woop! Ljubljana Trampoline Park equipment, the following limits shall apply:

1. Adults and children over the age of 15 may use the equipment without supervision after having signed the "Liability Waiver".
2. Children between the ages of 9 and 15 may use the equipment without supervision, after their legal representative has signed the "Liability Waiver".
3. Children between the ages of 3 and 9 may use the equipment solely if accompanied by their legal representative (the legal representative accompany the child on the trampolines and supervise the latter), after their legal representative has signed the "Liability Waiver".

To visit and use the equipment of the Woop! Ljubljana Trampoline Park, you are required to register on the website www.woopljubljana.si in advance. Registration is available for persons over the age of 15, who may also register family members under the age of 15, for whom they will sign the "Liability Waiver" (e.g. a parent can register both himself and his son who is younger than 15).

A person under the age of 15 may also register if he or she provides the name of at least one parent or legal guardian who will sign the "Liability Waiver" on their behalf.

Before your first visit and use of the park equipment, you must agree to the "Liability Waiver" during online registration, and then sign it in person at the park reception. Parents or legal guardians must sign on behalf of persons under the age of 15.

Upon ticket purchase and entrance to the free jump area, each visitor must also purchase special grip socks and a special (RFID) wristband. This wristband provides an access control system for the free jump area, the use of lockers and other park attractions. To enter the free jump area, all visitors must prove their identity with their wristbands and watch the safety instructions video. The wristband is non-transferable and can be used solely by the registered wristband user. In the case of misuse, your wristband will be confiscated by members of staff. Lost wristbands are subject to a replacement fee.

Safety rules to be followed by all jumpers:

- To enter the free jump area, you are required to wear grip socks, specially designed to prevent slipping, and special (RFID) wristbands.
- We recommend wearing lightweight sports clothing while jumping.
- While jumping, you must follow all safety instructions given by the park management and staff.
- Remove all jewelry and sharp objects before entering the free jump area.
- You must always act in accordance with the limitations of your body. This means you must not try to go beyond your physical capabilities; choose activities you know you can perform safely.
- If you wish to stop jumping, bend your knees.
- Always land with two feet and aim to stay in the middle of the trampoline.
- Always be aware of other jumpers.
- Two jumpers are never allowed to use the same trampoline simultaneously. If anyone steps onto your trampoline, stop jumping immediately.
- It is forbidden to jump on a trampoline, which is already in use.
- It is forbidden to land on your head or neck.
- It is forbidden to land on your back, unless you are on a vertical trampoline wall, for which previous experience is required.
- It is forbidden to jump on your head (air bag, foam pit).
- Head or neck shots are forbidden (during dodgeball).
- All somersaults are forbidden, except on the designated jump areas under the supervision of a park animator.
- Jumping from a trampoline onto the padding around the edge of the mat is forbidden.
- Lying on trampolines or mats is forbidden.
- Pushing other jumpers or running is not permitted.
- Climbing or grabbing safety netting is not allowed.
- Wearing wet clothing is forbidden.
- No food or drink is permitted on the trampolines (chewing gum, candy etc.).
- It is forbidden to use trampolines while under the influence of alcohol or drugs.
- Operating mobile phones while jumping is not allowed.

C: OPERATOR RESPONSIBILITIES

The Operator of the Woop! Ljubljana Trampoline Park is TPLJ d.o.o., Leskoškova cesta 2, 1000 Ljubljana (hereinafter: "the Operator").

The Operator will not be held responsible for any harm or damages caused to users and visitors or their possessions, unless caused by the Operator himself.

D: PERSONAL DATA PROTECTION

Personal information collected on the website is managed by TPLJ d.o.o., Leskoškova cesta 2, 1000 Ljubljana. The Operator will not disclose any personal data to third parties.

The Operator collects personal data only with your consent; data collection is completely voluntary.

Upon agreeing to disclose personal data, the Operator will store and manage your personal information; it will be used for the following purposes: direct communication, statistical analysis, consumer segmentation, analysis of prior consumer behavior, sending offers, materials and invitations, direct marketing (telephone, email, text message and direct mail marketing), as well as telephone, written and online surveys.

The Operator will protect and process your personal data in accordance with the current Personal Data Protection Act (ZVOP-1). Your personal data will be collected and used until your written revocation, which you can send to the following address: TPLJ, d.o.o., Leskoškova cesta 2, 1000 Ljubljana, or to the following e-mail address: info@woopljubljana.si.

E: VIDEO SURVEILLANCE

With regard to ensuring the safety of employees, visitors and physical property, as well as monitoring entry and exit of the park, the Woop! Ljubljana Trampoline Park uses a video surveillance system. The Operator has opted for video surveillance in accordance with the guidelines of the Personal Data Protection Act (ZVOP-1) and Article 75 on the surveillance of the commercial properties of the Woop! Ljubljana Trampoline Park. The personal data collected, which include video recordings, as well as the time and place of the recording, are protected from unauthorized access. Video recordings are stored for at least 30 days and up to one year; this applies to the video recordings of all cameras connected to the recording system. After the specified period of time, all data are deleted, with the exception of injury data.

F: USE OF PHOTOGRAPHS AND VIDEO RECORDINGS

Each visitor agrees that all photographs and video recordings made in the park may be made publicly available and published for advertising purposes and promotion of the Park. Such photographs and video recordings may appear on the following social media: Facebook, Instagram, Twitter, YouTube, LinkedIn and Snapchat. You also confirm that photographs taken in the park will not be used for commercial purposes without prior written consent.
